### United States of America: Core Beliefs

**Equality** - All people are created equally and discrimination against others is not permitted. **Life** - From the moment of birth, we have the right to be alive.

**Liberty** - We are free and autonomous people, and have the right to experience life, grow, learn and contribute to the world around us in ways that are meaningful to us. As long as we're not causing harm to others or violating another's rights, we have the right to do as we please.

**Pursuit of Happiness** - We have the right to explore, identify and do what brings us joy, peace, and happiness. This also includes the right to take well-informed risks and engage in things other people might not agree with. This is our life.

**We Own Our Government** - Government exists at the consent of the governed. All rights are already owned by each person. Our constitution grants certain, specific rights to act our collective behalf to secure our future.

#### United States of America: Guiding Principles for the Government

- **Bill of Rights** We are guided by the Bill of Rights; All rights not granted to the government are retained by individuals.
- Right to Redress We own the government and have a right to protest and petition the government to correct its actions.
- Freedom of Conscience & Religion Everyone has a right to their own religious beliefs; The government shall not respect anyone's particular religion nor allow them to interfere with another person's inalienable or civil rights.
- Freedom of Speech and Expression We believe all people have the right speak and express themselves freely.
- Freedom of Association We have the right to form bonds and relationships with others of our choosing.
- Self-Defense & the Right to Bear Arms We have a right to defend ourselves, and to keep and bear arms.
- **Privacy** We have a right to privacy in our thoughts, communications, property and effects.
- Private Property We have a right to own property and goods.
- Law & Order We believe laws and rules should be equally applicable, practical and fair.
- Adulthood & Voting We believe full legal rights should be assumed at the age of 18; All
  those who have reached adulthood have a right to vote.
- Freedom of Press We have a right to truthful, transparent and accurate information; We believe a free press is necessary to secure our freedom.
- **Justice** We believe that justice should be equal, fair and accessible, that all people are presumed innocent, and that no cruel or unusual punishment shall be inflicted.
